- a. Legal updates -Law suit status.
  - Linda Uhl's case is being handled by the insurance company. It is moving forward.
  - There is a hearing regarding the HOA lawsuit on Friday, Feb. 24, 2023 at 9AM before The Honorable Michael P. McDaniel, Hearing Room 5D1, Fifth Floor, Red Elevator, Polk County Courthouse, 255 North Broadway, in Bartow. It will be open to the public.

#### 11. Questions from the Floor

- A. Al Croucher had concerns about the new basketball hoop near the tennis courts. He wondered about rules, noise levels, and if residents nearby should register their complaints with the compliance committee. Rocco Guarino replied that there are no official new rules about the basketball hoop, but the current rules about guests under the age of 16 must be accompanied by their host resident do exist. It is expected that the host residents will monitor the behavior and noise level of their guests. If there is a problem, a complaint may be registered.
- B. Mindy Smith had concerns with the smell of eggs in her home's water and grayish brown water coming from the faucets. Rocco Guarino responded that Dan from Constant Flow is scheduled to be checking chlorine levels today. The grayish brown water is the result of lack of use of water in areas of the house, like guest bathrooms.
- C. Bill Heffner asked Rocco Guarino to repeat the location of the HOA Court's ruling. Rocco said that all those residents needing the Court House address info to stop the office for a printout.
- D. Carmen Wilde commented that this HOA Ruling is a very important meeting. She suggested that residents wanting to attend and to carpool should meet at the Club House at 7:45AM. This is a way we can show our support for our community.
- E. Shirley Tilley, 541 Paradise Point commented on her experience as a new resident trying to volunteer. She feels that the current way of volunteering and not getting a timely response from the committee chairs make new residents feel unwelcomed.

- Nancy Hayward replied that she has just recently talked with Shirley, apologized & explained the reason for the delay. As a result, Shirley will be a sub on the Compliance Committee.
- Rocco Guarino apologized and explained that Committee Chairpersons have the task of assembling their committees and to respond to those wanting to volunteer.
